**Plan Review Fee:** The minimum fee will be that which is listed in the fee schedule and deposited with the Administrator upon submission of the plan.

\*If the cost of reviewing the subdivision and/or land development exceeds the amount of the fee that the developer paid to the Township, the developer shall, prior to Township approval of the Plan, pay the Township the amount in excess of the Engineering & Solicitors fees (See Engineering & Solicitor Fees on Pages 4 and 5) that were expended in reviewing the subdivision and/or land development submission.

\*\*No Subdivision and/or land development plan shall be reviewed unless all prior unpaid fees have been paid, and no such plan shall be approved unless all fees have been paid in full.
